There can be no discrepancies in the totals recorded on this form, the totals entered on the Official County Canvassers' Statement and the precinct results certified for your county. Complete accuracy is of extreme importance as the totals entered on this form represent the official record of the election.
- 4.) After completing the form, affix all required signatures and county seal on the last page.
