



REQUIREMENTS FOR DRUG TESTING WHILE ON BOND

1. Call the Drug Testing HOTLINE at **(231) 627-8894** between the hours of **6:00 a.m. to 9:00 a.m.** every day.
 - **(Pay special attention to the message on the recording as this line is also being utilized for participants in the Cheboygan County Drug Court program):**
2. **LISTEN TO THE MESSAGE CAREFULLY AND COMPLETELY.** A recording will provide you with a letter or letters of the alphabet for each specific day (the recording changes daily).
3. If your **LAST NAME** begins with the letter on the recording, you must report to an agency for drug testing .
 - *If you have a hyphenated LAST NAME, we will be referring to the first letter of the first hyphenated name.*
4. **YOU** must instruct the testing agency to forward your results to the Cheboygan County Prosecutor's Office by 8:00 a.m. the next morning at (231) 627-8405.
5. It is **YOUR** responsibility to make sure the agency complies with the requirement so it is imperative that you instruct them to do so.
6. If you test, and your results are not faxed to the Prosecutor's Office by 8:00 a.m. as instructed, you may be in violation of your bond and an Order to Show Cause may be entered by the Court.
7. **In the event you are present for testing and results are not available by 8:00 a.m.; proof of your testing should be provided as instructed in paragraph #4 above.**

If you have any questions, and YOU ARE REPRESENTED BY AN ATTORNEY, please contact your attorney. The Court nor the Prosecutor are able to speak with you regarding these conditions.
