Shall the limitation on the amount of taxes which may be imposed on taxable property in the Township of Tuscarora, County of Cheboygan, Michigan, be increased by Fifty Cents (\$.50) per thousand dollars (\$1,000) (.5 mills) of the taxable value for a period of three (3) years, 2010 to 2012, inclusive, as new additional millage to provide funds for the purpose of acquiring, improving, maintaining, and supporting public parks and places of recreation in the Township? It is estimated that .50 mills would raise approximately \$105,000 when first levied in 2010.

On the Proposition **Tuscarora Township Parks and Places of Recreation Proposal** that **NO** received the largest number of notes and it is declared that said Proposition **FAILED**.
