

## ARTICLES OF REGULAR PROBATION

*All adjudicated minors are wards of this court who must abide by the following Articles of Intensive Probation these are the standard rules of probation however, your disposition report may contain additional terms or they may be somewhat different than those contained here (for example: you must maintain a B average rather than the C average noted here). If they differ the court order is the rule you must follow:*

*You must obey all federal and state laws, and all ordinances.*

*If school is in session and you are not suspended or expelled, you are to be in school every day, on time, unless excused by a parent up to 5 days per trimester or semester. All absences after 5 days will require a doctor's note or verified appointment to excuse an absence- a parent call-in without a verified appointment is not considered a valid excused absence after 5 absences per trimester while on probation. All absences past 5 per trimester/semester will subject you to court sanctions and possible intervention by the school liaison/truancy officer.*

*You are to attend every class, complete assigned work, including homework, maintain a C average, work to the best of your ability, and control your behavior as well as your language at all times.*

*If you are suspended or expelled from school at any time you are not to be outside the family home during school hours unless you are with a parent or have permission from your Probation Officer.*

*You are to attend school and follow all school rules, and your parent, guardian, or custodian must notify the court of any school absences. Suspensions, or violations of school rules, are considered violations of probation and may lead to further court consequences.*

*Your parents must approve at all times: who you are with, where you are going, when you will be and how you will get home.*

*You must respect and comply with home rules and directives from your parents, and you must also respect persons of authority outside the home.*

*You must comply with a search of your person or property and seizure at the direction of your probation officer.*

*You must obtain court permission to leave Cheboygan County or the State of Michigan.*

*You and your parents must cooperate in the obtaining of professional services ordered by the court prior to, at or after the disposition hearing. This includes psychological assessments, risk assessments, substance use assessments, psychiatric evaluations, physical examinations and court ordered mediation services.*

*You must not keep company with any person your parents or the court doesn't approve. This includes any person on probation in the juvenile court or the adult court system.*

*If you are placed under house arrest with nightly call-in with a parent or guardian, you are only allowed to be out of the home without a parent for school, school activities, counseling, medical appointments or community service. Any other reason must be approved by your probation officer. Once house arrest is over, standard curfew is 8:00 PM on weekdays, and 10:00 PM on weekends. You can be out after curfew if you are employed or on your way home from work. If you are not employed you must be with a parent or responsible adult after curfew.*

*You must meet with your caseworker as directed, a minimum of once a month, and possibly, as often as once a day. You cannot have overnight visits with a friend for the first thirty days, after the first thirty days, it is allowed with permission from your probation officer.*

*You must not use or consume alcohol and/or illegal drugs, and you must not associate with any person who does. Prescription drugs can only be used as prescriptions under the direction of your parent(s).*

*You must not be in possession of drug paraphernalia, and you must submit to random drug screens either observed or unobserved or PBT's as directed by your probation officer and in the event of a positive drug screen you will be required to complete a substance abuse assessment.*

*The juvenile shall not possess use or consume alcohol or illegal drugs including tobacco/nicotine or any product including synthetic cannabinoids or tobacco (whether legal or illegal to possess) for the purpose of causing a condition of intoxication, euphoria, excitement, exhilaration or dulling of the senses or nervous system, intentionally smell or inhale the fumes of any product into his/her respiratory or*

*circulatory system. This shall not prohibit the inhalation of any anesthesia for medical or dental purposes.*

*The juvenile also shall not associate with people that are illegally using alcohol, using illegal drugs or legal substances in violation of the above.*

*Drug screens that are positive even for synthetics such as K2, spice or bath salts and others, can be treated as a probation violation like any other positive drug screen.*

*The Juvenile shall not use or possess E-Cigarettes/ Vape Pens or any devise used to smoke or inhale tobacco or substitute tobacco product.*

*You and your parents must participate in the court's P.O.P. program, an after-hours probation contact at your home. Contacts will be random and at the discretion of your probation officer.*

*Parents are expected to enforce orders of the court, and the juvenile or parent(s) are expected to inform the court of violations. Parent(s) must pay the ward's court costs when the ward fails to pay, and the parent(s) supervising a ward at the time of his/her offense must pay restitution costs if/ when the minor fails to pay. This is in accordance with Public Act 239. Payment plans must be arranged with the court.*

**PROBATION TERMS AGREEMENT**

Juvenile:

*I understand that violating any of my probation terms will result in further court consequences, such as: restricted curfew, loss of privileges (including driving privileges), additional community service work, closed campus at school, tutoring, tether and / or additional time on probation. It may also result in a Probation Violation Hearing and / or out of home placement.*
